THESE UPSCALE HUNTERS AND FISHERMEN PURCHASE ITEMS SUCH AS SUV'S, TRUCKS, ATV'S, FISHING TACKLE, RIFLES, SHOTGUNS, PISTOLS, ARCHERY EQUIPMENT CAMPING AND COOKING SUPPLIES, BOATS AND MOTORS, OUTER WEAR, DEER STANDS AND FEEDERS, GPS UNITS, DECOYS, AND AMMUNITION. THEY ENJOY UPPER INCOMES AND OFTEN SPEND MORE THAN \$10,000 PER EXPEDITION TO BAG THAT TROPHY MOUNT.
